

Procedure for Participation in Training and Cooperation Activities (TCA) and Networking Activities (NET) in the Youth Sector

1. Application for Participation

Interested eligible applicants from Cyprus are invited to submit an application for participation in the eligible activities published by the Foundation for the Management of European Lifelong Learning Programmes (IDEP Lifelong Learning).

[Applications for participation are submitted electronically via the SALTO Youth platform](#), through the relevant link for each activity, which is included in the call published for each period.

2. Approval of Participation

The approval of participation of beneficiaries from Cyprus in the activities is carried out by the National Agency of Cyprus (IDEP Lifelong Learning).

The final selection of participants for each activity is made by the organisers.

In the event of approval of their participation, beneficiaries will receive an official approval letter from IDEP Lifelong Learning, which will include detailed information on the amount of the grant for their participation in the specific activity.

Applicants are required to confirm their interest in participation in writing within 5 days.

3. Funding Agreement

The funding agreement is signed electronically by the beneficiary, the head of the organisation (where applicable), and IDEP Lifelong Learning, prior to the start of the activity.

Upon signing the agreement, the pre-financing amount (70% of the total funding) is transferred to the beneficiary's account.

4. Final Report

Within 30 days of the completion of the activity, the beneficiary is required to complete and submit to IDEP Lifelong Learning the Final Report together with the necessary supporting documents. The submission of the Final Report automatically constitutes the request for payment of the remaining funding amount, if applicable.

In case where the pre-financing amount, already paid, exceeds the funding amount requested by the beneficiary through the Final Report, the beneficiary will be required to return the corresponding excess amount.

Funding

The costs covered for the participation of selected beneficiaries are as follows:

- **Travel costs**

This cost category covers both the purchase of airline tickets and travel to and from the airports in Cyprus and the destination country. It provides a fixed amount per destination country, which cannot be increased.

Travel costs are calculated based on the distance in kilometres from the city of the sending organisation to the city where the seminar/workshop is implemented.

The distance calculation is carried out using the EU [Distance Calculator tool](#).

- **Subsistence costs**

Subsistence costs are covered for up to two travel days that beneficiaries may incur, where necessary and not covered by the organisers. In cases where subsistence costs during the working days of the seminar are not covered by the organiser, these costs are also included under this category.
